

MEMORANDUM OF UNDERSTANDING

(The Party of the First Part and Second Part shall be individually referred to as a “Party” and collectively referred to as the “Parties”, as the context may require).

WHEREAS,

- A. The Party of the First Part is Medical college run as per the norms of National Medical Commission. The first party is giving education to Undergraduate & Postgraduate students and also training to Interns.

- B. The party of the Second Part is Lakulish Yoga University interested in supporting training of Interns as well as medical students.
- C. The Party of the First Part wishes that interested interns can come to your esteemed instituteto learn about “Yoga for Health” in small batches for the duration of 1 week.
- D. The Party of the Second Part is also willing to impart training as mentioned above with following conditions.

NO Wit is agreed between the parties as under:

1. There will not be any financial transaction about this activity.
2. The Party of the Second Part will be the in charge of batch of interns posted for the duration of 1 week. All the decisions relating to the several activities related to training such syllabus, theory teaching, practical teaching etc will be governed by second party.
3. At the end of 1 week completion of training certificate will be issued by authorized person of Second Party.
4. First party will help voluntarily to impart knowledge to yoga students also as per mutual convenience.
5. The arrangement is made for 2 years and subsequently, after completion of 2 years both the parties may decide the future plan.

All notices and other communications under this MOU shall be in writing and shall be deemed given when delivered personally or mailed by registered mail, return receipt requested, to the parties at the following addresses (or to such address as a party may have specified by notice given to the other party pursuant to this provision):

Venue of Arbitration shall be at Ahmedabad. Court sat Vadodara shall have an exclusive jurisdiction in connection with all the matters pertaining to this MOU.

8. Each Party shall have the right to terminate the Memorandum of Understanding by giving 01 months written notice in writing to the other Party at any time. If the MOU is terminated by either Party, steps shall be taken to ensure that the termination does not affect any Party.






